# <u>Conditions of participation and data protection information for the "Show us your Outletcity"</u> <u>competition</u>

The organiser of the "Show us your Outletcity" competition (hereinafter referred to as the "**competition**") is OUTLETCITY METZINGEN GmbH, Friedrich-Herrmann-Str. 6, 72555 Metzingen, Germany (hereinafter referred to as "**OUTLETCITY METZINGEN**").

The following conditions of participation apply to anyone wishing to enter the competition. By choosing to enter the competition, you are confirming that you accept these conditions.

- The competition will be run on a monthly basis, starting in September 2020. The competition will officially open at 00:00 on the first day of each calendar month and close at 23:59 on the last day of each calendar month (hereinafter referred to as the "monthly competition period").
- 2. One prize will be up for grabs within each monthly competition period. The winner of the prize will be announced each month. The prize is currently:

A shopping voucher worth EUR 250.00 to spend at participating outlet stores at OUTLETCITY METZINGEN (not valid online). The voucher terms and conditions will apply.

- 3. You must enter the competition on Instagram. You can access the terms of use for Instagram here: <u>https://www.facebook.com/help/instagram/478745558852511</u>.
- 4. All residents of Germany aged 18 or over are eligible to enter the competition. You are not permitted to enter the competition if you work for OUTLETCITY METZINGEN or HOLY AG and your entry will not be counted.
- 5. If you wish to enter the competition, post a photo of OUTLETCITY METZINGEN on your own public Instagram account within the monthly competition period. You must have taken the photo yourself. You must also use the hashtag "#outletcityXpics" and tag the "@outletcity\_metzingen" Instagram account. Including the relevant hashtag and tagging the relevant account counts as confirmation that you have read and accepted the conditions of participation.

PLEASE NOTE: Photos will only be accepted as competition entries if they do not break the law and do not become the subject of any other complaint. When you enter the competition, it is your responsibility to ensure that your photo is not pornographic, racist, otherwise offensive or illegal. You must also be sure that your photo does not violate any copyright or trademark rights.

6. OUTLETCITY METZINGEN will use its own discretion when determining the winner and awarding the prize. To do so, OUTLETCITY METZINGEN will ask a judging panel to nominate two photos. OUTLETCITY METZINGEN will then share these photos on its Instagram story and ask its followers to vote for their favourite by liking it. The photo with the most likes will be declared the winner. The winner for any given monthly competition period will be determined by the 14th day of the following month.

The winning photo will be posted by OUTLETCITY METZINGEN in a story on its "Outletcity Metzingen" Instagram account by the 14th day of the month following the relevant monthly competition period. OUTLETCITY METZINGEN will also send the winner a private message to inform them directly that they have won the competition and explain how they can claim their prize. If the winner does not acknowledge that they have won within three days (as explained in the private message they will have received), or if it is not possible to get hold of the winner through their account, they will forfeit their claim to the prize. If this happens, OUTLETCITY METZINGEN reserves the right to choose another winner for that monthly competition period and post their photo accordingly.

- 7. OUTLETCITY METZINGEN will not be held liable for any material or legal defects relating to the prizes or any other defects that arise or may arise in association with the prizes.
- 8. OUTLETCITY METZINGEN cannot guarantee that its Instagram account, or the content posted on that account in relation to the competition, will be available or functioning fully. Above all, OUTLETCITY METZINGEN cannot guarantee that photos will not be deleted, corrupted or lost as a result of a technical fault or human error.
- 9. OUTLETCITY METZINGEN reserves the right to disqualify entrants from the competition when there is good cause to do so, such as if the entrant is found to be in breach of these conditions of participation or is suspected of rigging the competition in some way.

- There is no cash alternative to the prize. The competition is open to individual entrants only gambling associations, competition service providers and the like are not permitted to enter. Prizes may not be transferred or exchanged.
- 11. OUTLETCITY METZINGEN also reserves the right to close the competition early at any point, without prior notice, and may alter the conditions of participation as it sees fit. Most significantly, OUTLETCITY METZINGEN will be authorised to act in this way if technical, legal or economic reasons dictate that it is no longer possible to run the competition properly or that the competition is no longer feasible.
- 12. The competition is not affiliated with Instagram in any way and Instagram is not playing any part in sponsoring, supporting or organising it.

#### 13. Usage rights for competition entries

Upon entering the competition, you grant OUTLETCITY METZINGEN non-exclusive, transferable and sub-licensable usage rights to the photo you have posted with no limitation on location, time or content. OUTLETCITY METZINGEN therefore has the right to process, use, share, copy, publicly present and display the posted photo, especially as part of photo galleries or lists. When you enter the competition, you expressly agree to your photo being used free of charge by OUTLETCITY METZINGEN on its web pages, especially on outletcity.com, for marketing purposes online and offline – with no limitation on location, time or content. You also agree to your photo being used accordingly on apps for smartphones and other similar devices and on the social media accounts run by OUTLETCITY METZINGEN on Facebook, YouTube and Instagram.

You are entitled to inform OUTLETCITY METZINGEN that you wish to withdraw this transfer of rights at any point with future effect. You can also withdraw this transfer of rights yourself at any point by deleting your content or account. However, please remember that your content will not be fully deleted if it has been shared with others who have not deleted it too.

Please note that OUTLETCITY METZINGEN is only responsible for the content posted on its own web pages/social media accounts and cannot accept any liability in the event that third parties unlawfully share photos entered into the competition. OUTLETCITY METZINGEN will not be held liable for material or immaterial damage caused by posts on social media relating to the competition provided that there is no proof suggesting that there was any malicious intent or gross negligence on the part of the author.

Please also note that photos entered into the competition may also appear in lists of results generated by search engines.

### 14. Copyright

When you enter the competition, you must confirm that you have all the rights to the photo you have posted and unrestricted exploitation rights of all parts of the photo, that no third parties have rights over the photo and that no rights to privacy are violated by images of people. If any identifiable people appear in your photo, you must have asked them to give their consent to the photo being posted. You will need to confirm this in writing if requested to do so. When you enter the competition, you confirm that OUTLETCITY METZINGEN will not be held responsible in the event that third parties do end up asserting claims on the basis of their rights being violated.

15. The law of the Federal Republic of Germany will apply exclusively to the competition. The organiser's decision is final as regards the running of the competition, deciding upon the winners and awarding the prizes.

#### 2. Purposes of data processing and data storage period

We will also need to be able to provide evidence that we have conducted ourselves properly when determining the winners and awarding the prizes within the statutory limitation periods where required.
